## **Purpose and Outcome**

**Course Overview:** This 3-credit course is a sophisticated introduction to the concepts and methods of biostatistical data analysis. The topics include descriptive statistics, probability, standard probability distributions, sampling distributions, point and confidence interval

estimation, hypothesis testing, power and sample size estimation, one and two-sample parametric and non-parametric methods for analyzing continuous or discrete data, and simple linear regression. The SAS statistical software package will be taught in this class for data management and statistical analyses.

**Relation to Program Outcomes:** This three-credit course is a required concentration core course for MPH Biostatistics students and covers the following competencies:

- Analyze quantitative and qualitative data using biostatistics, informatics computer-based programming and software, as appropriate.
- Communicate audience-appropriate public health content, both in writing and through oral presentation.

**Course Objectives and/or Goals:** Upon successful completion of the course, students will be able to:

- CO-1: Describe the role biostatistics serves in the discipline of public health.
- CO-2: Differentiate among different sampling methods and discuss their strengths and limitations.
- CO-3: Describe the strengths and limitations of designed experiments and observational studies.
- CO-4: Distinguish among different measurement scales, choose the appropriate descriptive and inferential statistical methods based on these distinctions, and interpret the results.
- CO-5: Determine preferred methodological alternatives to commonly used statistical methods when assumptions are not met.
- CO-6: Apply basic concepts of probability, random variation, and commonly used statistical probability distributions.
- CO-7: Use statistical software to analyze public health data.
- CO-8: Develop presentations based on statistical analyses for both public health professionals and educated lay audiences.

**Instructional Methods:** This course is presented using a mix of lectures and group activities. Lectures will generally be given Mondays and activities or discussions will take place on Thursdays. You should review the materials provided in the online textbook prior to the corresponding lecture.

- 1) Direct purchase and installation. This option is only available for Windows users..SAS can be purchased on campus at the UF computing help desk located at 132 HUB Stadium Road (<https://software.ufl.edu/software-listings/sas.html>). Click on the SAS Student page for SAS program purchase information and online documents.
- 2) SAS is also available, along with other applications such as Microsoft Office, on the free UFApps server (<https://info.apps.ufl.edu>). This may be the best option for Mac users. To use SAS on UFApps, you will need to learn how to upload and download files to and from the UFApps server. See the Using SAS on UFApps document for specific instructions.
- 3) SAS also has a free virtual app called SAS University Edition. For more information and to download the needed software, see [https://www.sas.com/en\\_us/software/university-edition.html](https://www.sas.com/en_us/software/university-edition.html). It can be used with Windows, OS X, and LINUX systems.
- 4) For some departments, SAS may also be available through their IT group or remote desktop. Check with your own department for SAS access.

## Academic Requirements and Grading

**Assignments:** Grades will be based on quizzes, homework assignments, and the course project..

- There will be untimed **quizzes** in Canvas covering the material from the previous week. You can take each quiz up to three times before the due date, and your highest score will be recorded. When you submit a quiz attempt, you will see your grade and be able to review your responses with feedback. We highly recommend that you start your first attempt early and take your three attempts on different days with time for reviewing the course material in between.
- **Homework assignments** will involve data analysis using SAS and/or questions which cannot be easily presented in quizzes. These should be started well ahead of the due date.
- Each student will individually perform a **course project** consisting of a guided data analysis based upon two (hopefully linearly related) quantitative variables. The relationship between the two variables will be investigated using different approaches. This course project will be completed in 4 steps during the semester.
