#### **PURPOSE AND OUTCOMES**

#### **Course Overview**

The course aims to provide a broad introduction to public health and how it relates to health care administration. The course includes understanding how the health professions and specialized health research contribute to achieving public health goals.

## **Relation to Program Outcomes**

Students pursuing degrees within the UF College of Public Health and Health Professions must be grounded in fundamental public health knowledge, including sub-disciplines of epidemiology, biostatistics, biomedical sciences, environmental health science, social and behavioral sciences, and health policy and management. The course objectives, assignments, and activities are designed to contribute towards mastery of critical competencies in the Master of Health Administration (MHA) curriculum. Also, with changes in care and payment models, many healthcare organizations are looking at how they can influence factors outside their delivery systems to improve community health.

# **Course Objectives and Goals**

Upon completion of this course, students will be able to:

- Demonstrate fundamental knowledge in the public health sub-disciplines.
- Discuss the history of public health in the United States.
- Relate the social-ecological model to public health research and services.
- Describe the core functions and essential services of public health and how they relate to healthcare management.
- Describe how health is measured and compared across regions or populations.
- Discuss the structure of the public health system in the United States and its relationship to the healthcare system.
- Specify how public health interventions are created, implemented, and evaluated.
- Demonstrate how discipline-specific research contributes to population health.
- Apply public health principles and practices to healthcare management scenarios.

# **Instructional Methods**

The course is housed in UF e-Learning in Canvas. Your participation in the class is vital to your success. Be prepared to participate in each class; students will be called on randomly if voluntary participation lags.

#### Tests

Tests are primarily multiple choice and 1-3 short answer questions. The tested material includes PowerPoints, lectures, class discussions, team presentations, assigned readings in the textbook, and selected supplemental readings. The tests are not cumulative and focus on the information presented in specific modules. However, many concepts learned at the beginning of class are built upon and repeated or applied in subsequent tests.

# In-class Assignments, Homework, and Quizzes

Multiple graded in-class assignments, homework, and quizzes will occur throughout the semester. Examples include creating and giving a presentation on an assigned topic, leading an exercise applying a public health practice in a healthcare management scenario, and writing a position paper. More details will be posted in Canvas.

#### **Attendance**

Students are expected to arrive for class on time, prepared and ready to participate in class discussions. The instructor will conduct "random in-class attendance check" assignments throughout the semester. Students who earn 100% on these checks will have five bonus points added to their lowest test score. Late submissions are not encouraged but will be accepted for up to 7 days, but with the following policies and penalty schedule: It may be possible to avoid a late penalty if you contact the instructor at least 24 hours in advance. In some cases, documentation may be requested. If a lateness allowance is agreed to, this applies to a single assignment. It does not allow you to delay future assignments.

If your assignment is late, you will lose 10% each day. Thus, if an assignment is worth 30 points, you will lose 3 points for each late day. "Late" begins one minute after the due time (e.g., an assignment due at 8:34 am is considered late at 8:35 am). Penalties are as follows:
